## **LATE ENTRIES WILL NOT BE ACCEPTED ENTRIES CLOSE: 15<sup>th</sup> February 2019**

This section to be run under the By-Laws and Regulations of the Newcastle A H & I Association. Exhibitors entering **more than 10 entries** by the closing date, will receive ONE (1) free Entry Pass into the Showground. **A stamped self-addressed envelope must be forwarded with Entry Forms.**

Different Exhibitors in the one family **MUST FORWARD SEPARATE ENTRY FORMS** and pay **SEPARATE ENTRY FEE**. The Waiver Form **MUST** be completed and enclosed with the Entry Form/s.

MEMBERSHIP OF THE ASSOCIATION: Membership subscription for 2019 is \$25.00 and Members may also purchase tickets for guests at \$12.00 and children at \$8.00 which allow them entry for the 3 days of the Show. Please pay Membership on a *separate cheque* to your Rat or Mouse Entry Form. Membership Application must be paid before the 31<sup>st</sup> January 2019.

## **PLEASE KEEP A RECORD OF YOUR ENTRIES. PEN NUMBERS AND ENTRY FEE RECEIPTS WILL BE ALLOCATED AT THE TIME OF VETTING.**

### **CONDITIONS:**

All care will be taken with entries but the Association does not accept any responsibility for theft or damage.

STAGING & VENUE: Entries to be staged in Bramble Road Pavilion between the hours of 7am and 9am on Sunday 3rd March 2019. Exhibits not staged by the time stated will not be accepted. Exhibits are to be brought to Newcastle Showground. Judging will take place on **SUNDAY 3rd MARCH 2019 at 10AM.**

Entries are permitted to enter the showground via the Griffith Road entrance to drop off exhibits and then remove vehicles from grounds. There is **NO** parking in the Showground and **ALL** drops offs are to be completed and vehicles removed by 8.30am (no exceptions).

ENTRY FEES: **to be paid before 15<sup>th</sup> Feb 2019**

NON Members \$1.50 per entry

VETTING STARTS: 7AM-9AM ON SUNDAY 3<sup>rd</sup> MARCH 2019

JUDGING COMMENCES: 10AM SHARP. Judge's decision is final.

No talking is permitted at the judging table. Any communications must be ceased until the judging of that class has concluded. Any exhibitor making comments about other animals may risk their animal being disqualified and exhibitor being removed from the area.

COLLECTION: Exhibits to be collected on Sunday the 4<sup>th</sup> March 2018. Entries can be removed after presentation but **no vehicle entry to the grounds will be permitted until after 4pm.**

Rats and mice, other than Exhibits shall not be allowed in show pavilion without Chief Steward's permission. All rats and mice exhibited at the Show must be fed and watered by the exhibitor. **Sick or diseased** animals will be removed from the pavilion along with lice infested, pregnant, lactating and dirty animals. All animals must be brought into the pavilion in a suitable carry receptacle. Any Exhibit which cannot be handled by the judges in a manner suitable to be judged will be disqualified. Use of any substances must be approved by the Chief Steward. The Newcastle A.H. & I Association would like to thank the NSW Fancy Rodent Society Committee for their help in preparing the Schedule and running the event.

### **Section A – General Acknowledgement**

**Agricultural Societies Council of New South Wales Limited and Newcastle AH&I Assoc Inc T/a Newcastle Regional Show (together the Suppliers) advise that participation (including passive participation) in animal handling or physical competitions or Events at an agricultural show contains elements of risk, both obvious and inherent.**

**The handling of animals if applicable is a dangerous recreational activity as animals can act in a sudden and unpredictable way, especially when frightened or hurt.**

**Physical competitions, activities and events of all types are dangerous recreational activities.**

1. By signing this waiver I acknowledge that:

1.1 participation in the Event is a recreational service for the purposes of section 139A of the Australian Competition and Consumer Act (Cth) 2010, and also a recreational activity for the purposes of section 5K of the Civil Liability Act (NSW) 2002;

1.2 participation in the Event is a hazardous activity and involves a significant risk of physical harm and may result in injury, loss, damage or death to me;

1.3 participation in the Event requires certain skills and experience. I declare that I have sufficient skills and experience to be able to safely and properly participate in the Event;

1.4 if applicable to the Event, animals can act in a sudden and unpredictable ways, especially if frightened or hurt, or if exposed to loud or unfamiliar noises;

1.5 the Event will be held in close proximity to rides and large groups of people, and that there may be loud and unfamiliar noises which can frighten animals used in the Event, if applicable;

1.6 if the event is held outdoors, there are risks to me as a result of the weather conditions, including either extreme hot or cold weather, rain or wind;

1.7 insects or other animals may cause animals used in the Event, if applicable, to become frightened and act in an unpredictable way;

1.8 if the Event involves the handling of animals, there is a risk of suffering injury including injuries caused by animals;

1.9 I am responsible for ensuring that I have and will wear equipment suitable for my safety in my participation the Event;

1.10 I am responsible for the condition of any tools and equipment and ensuring that they are appropriate for the Event; and

1.11 I use the facilities supplied for the Event entirely at my own risk, as I find them and with the prior acceptance of the risk of possible danger to me.

**2. If I suffer personal injury or death while participating in an animal handling event, I will not hold the Suppliers, their employees or agents legally responsible for any personal injury or death I suffer. I will not sue the Suppliers, their employees or agents for any claims, costs, damages or liability. I agree to release the Suppliers and their employees from legal responsibility for the services I have been provided and/or activity I have participated in.**

**3. I acknowledge and agree that my participation in the event and associated activities is dangerous and may have inherent risks as a result of which personal injury (and sometimes death) may occur. I acknowledge that the event and associated activities carry with them a significant risk of physical harm. I accept and assume all such risks of personal injury or death in anyway**



whatsoever arising from these activities and hereby waive my individual right to sue the Suppliers for all claims I may have for such personal injury or death against the Suppliers in any way whatsoever arising from or in connection with these activities.
